

: MEMORANDUM OF UNDERSTANDING :

This memorandum of Understanding (MOU) is executed at Tumkur on 01-02-2023

Between

President and PDO (Panchayath Development Officer) of Mydala Gram Panchayath that comes under Oordigere Hobli, Tumakuru Taluk and District.

And

NSS Units of Sree Siddaganga College of Arts, Science and Commerce incorporated under Sree Siddaganga Education Society(R) that has its registered office at B.H Road, state highway No. 33, near Town Hall, Gandhi Nagar, Tumakuru, 572102. (hereafter referred to as "partner institute")

President and PDO of Mydala Gram Panchayath and partner institute shall individually be referred to as "party" and collectively as "parties".

Ayyanapalya is a village that comes in the limits of Mydala Gram Panchayath, Oordigere Hobli, Tumkur Taluk and Tumkur District.

Partner Institute is a well known institute in Karnataka, India. That offers different programmes to students.

Therefore it is hereby agreed and declared by and between the parties as follows:

1. Principle understanding

Pursuant to mutual discussion and understanding

- 1.1 Partner Institute is willing to adopt Ayyanapalya . President and the PDO of Mydala Gram Panchayath grant permission to adopt and develop the village.
- 1.2 Sree Siddaganga College of Arts, Science and Commerce has agreed to extend its Support in the community development activity of Ayyanapalya of Mydala Gram Panchayath.
- 1.3 The students of the institution shall have an access to participate in the Developmental activities.
- 1.4 Mydala Gram Panchayath supports the institution and its students to develop Community skills.

- 1.5 The partner institute shall not misuse the village or villagers for other purposes.
- 1.6 The partner institute's development activities will abide by the consent of the Villagers.
- 1.7 The Institution will plant trees where ever required.
- 1.8 The Institution will give importance to cleanliness and hygienic factors.
- 1.9 The Institution will look into the education of students by providing them books, pens, pencils and uniform.
- 1.10 The institution intends to cause awareness among the villagers about health, importance of education, social responsibilities, and hygienic factors.

2. TERM

Unless terminated earlier, the term of this MOU shall be valid for a period of one year Commencing from 01-02-2023 until further it is agreed between the parties that not withstanding anything contained under this MOU. The parties shall not be entitled to terminate this MOU during the period from the commencement of it. However, prior to the expiry of the term, the parties May mutually agree to renew this MOU.

3. REPRESENTATION AND WARRANTIES

Each party to this MOU makes the following representation and warranties.

1. The person signing this MOU has the legal power and authority by virtue of statute /resolution, to sign this MOU for and on behalf of the parties and to perform and Comply with its duties and obligations.
2. This MOU constitutes legal, valid and binding obligation enforceable against it in Accordance with the terms hereof and represents that there is no contract, agreement. or understanding with any person, partnership or any other entity/ authority restricting or preventing it from performing its obligations/ deliverables under this MOU.

4. INDEMNITY

Each party shall indemnify, save and hold fully harmless the other party from against Any/ all claims, losses, liabilities, actions, claims, suits, proceedings,(including any Proceeding brought before any court, regulatory body, arbitration panel or other Tribunal) damages, judgments arising out of or in any way connected with any breach of any representation, warranty and / or any terms under this MOU.

5. CONFIDENTIALITY

It is agreed that both the parties shall maintain confidentiality and mutual trust.

6. FORCE MAJEURE

Neither party shall be liable for delay in performance of its responsibilities / Obligations hereunder which may be caused by an act which is beyond the reasonable Control of either party. Should the Force Majeure Event subsist for a duration longer Than 60 (sixty) days, the parties shall mutually agree the way forward including the right To terminate this MOU by serving a 90 (ninety) days' prior written notice.

7. GOVERNING LAW

This MOU shall be governed by the applicable laws of India.

8. NOTICES

All notices or other communication to be provided under this MOU shall be in writing And may be communicated either through registered post or e-mail.

9. ENTIRE AGREEMENT

This MOU constitutes the entire agreement between the parties with respect to the subject matter of the MOU and supersedes all communications, negotiations and agreements between the parties made prior to this MOU.

10. RELATIONSHIP



11. AMENDMENT


No amendment or other variation of this MOU shall be effective unless it is in writing, is dated and expressly refers to this MOU, and is duly signed by the authorized Representative of each party.
