
#### **STUDENTS' FEEDBACK 2022-23**

- The majority of students believe that the assessments accurately measure their attainment of learning outcomes, indicating confidence in the evaluation methods.
- The scope for acquiring employability and entrepreneurship skills through the curriculum has received mixed feedback, with a notable proportion of students expressing neutrality.


#### **Conclusion:**

- The relevance of open elective syllabi and the potential for acquiring employability and entrepreneurship skills garnered mixed feedback.



- The relevance of open elective syllabi and the potential for acquiring employability and entrepreneurship skills received mixed feedback.



- 1. The majority of teachers (80.4%) find the syllabus suitable for their respective courses, with a significant percentage agreeing that it is well-suited.
- 2. A substantial percentage of teachers (68.6%) believe that the objectives of the curriculum are well defined and clear to both teachers and students.
- 3. A majority of teachers (74.5%) appreciate the balance between theory and application in the curriculum.
- 4. Most teachers (76.5%) find that the books prescribed/listed as reference materials are relevant and appropriate.
- 5. A significant number of teachers (74.5%) believe that a sufficient number of prescribed books are available in the library.
- 6. Approximately two-thirds of teachers (66.6%) feel they have the freedom to propose, modify, suggest, and incorporate new topics in the syllabus through proper channels.
- 7. A majority of teachers (82.4%) feel that the course/syllabus has made them interested in the subject area.
- 8. A significant percentage of teachers (82.4%) believe that the course/program has increased their knowledge and perspective in the subject area.
- 9. Teachers express satisfaction (78.4%) with the number of optional papers available in the course/programme of studies.
- 10. A majority of teachers (72.6%) believe that the curriculum has enhanced students' employability.

#### Conclusion:

The feedback provided by teachers through this curriculum evaluation survey offers valuable insights into the curriculum's effectiveness and alignment with their expectations. Overall, teachers expressed satisfaction with the suitability of the syllabus, clarity of objectives, and the balance between theory and application. The findings will be instrumental in further improving the curriculum to better serve the needs of both teachers and students.




